# Titration:

9.4 g/L x mL

Titrate 5 mL of the solution against 0.5 N Hydrochloric Acid using Methyl Orange as the indicator.

# Foam Behaviour:

Slightly foaming at 30 °C, sprayable at 50 °C.

# **Emulsifying effect:**

Oils free of emulgators are not emulsified.

# **Equipment:**

Mild steel. The tanks must not be activated by sand-blasting or corrosive acids.

#### **Effluent Information:**

There are no totoxic substances in BONDERITE C-AK 62029, but the alkali value of spent solutions may be too high

Neutralization with acid, and subsequent filtration, may be required before the neutralized solution can be discharged to the drainage.

1.3 kg of a 25 % solution of Sulphuric Acid is needed for the neutralisation of 1 kg BONDERITE C-AK 62029 .
