1.5 to 10 kg of BONDERITE M-AD 3180.

## **Bath Control:**

Control the bath through determination of pH value. Replenishments must be made to maintain the value as constant as possible.

# Replenishment:

For an optimal neutralizing / passivating action frequent controls are needed. Whenever the amount of BONDERITE M-AD 3180 used for replenishment exceeds the amount of the product used at the start up, renew complete the bath.
