APPLICATION FIELD

Pattex Textile Adhesive is suitable for bonding fabrics including cotton, denim, linen, felt, blended and synthetic fabrics. The adhesive is suitable for bonding fabrics to a wide range of materials including leather, wood and metal.

INSTRUCTIONS FOR USE

Preparation

Surfaces must be clean, dry and close fitting.

Application

- 1. Apply a thin, even coat of adhesive to both surfaces, especially at the edges.
- 2. Carefully align the parts and press together firmly. Allow to dry for 30 minutes.
- 3. Iron the bonded area
- 4. Allow to dry for 24 hours

Note:

- In case of fine textiles, a trial on one edge is recommended
- Fresh, uncured adhesive can be removed with water
