#### Pretreatment:

The substrate should be clean, dry, free of dust, oil, grease and other contaminants.

#### **Application:**

Application Temperature: 225 to 250°C

When bonding to a substrate with high thermal conductivity the use of a specific application temperature is required for good wetting. Do not heat the product above the specified application temperature range.

When the product is not in use do not apply heat, this will degrade the quality of the product and in extreme cases cause carbonization. TECHNOMELT<sup>®</sup> PA 2692 N may absorb moisture from the air. This will not be apparent in the solid form, but may cause bubbles on heating and could affect the bond quality. It is important, therefore, that containers are kept closed and sealed when not in use.

#### Cleaning:

Carbonized and set (non thermoplastic) material must be removed mechanically. Removal of the thermoplastic material from the hot apparatus can be achieved with solvent free cleaning system, such as TECHNOMELT<sup>®</sup> PA 62 (see separate technical information). Cleaners may not be available in all regions.

#### Storage:

Store in a cool, dry location, with the container tightly closed. This product has a 2 year shelf life from date of manufacture in original, unopened package.

#### Packaging

TECHNOMELT<sup>®</sup> PA 2692 N is supplied as granules for ease and handling. This product comes packaged in moisture tight bags containing 18.14 kg (40 pounds) net.
