TEROSON PU 8545 UV is a solvent borne, thin liquid cleaner / activator which contains silanes. It is free from chlorinated hydrocarbons, aromatic solvents and from isocyanates.

APPLICATION AREAS

TEROSON PU 8545 UV is used for cleaning and activation of organic or inorganic surfaces (like ceramic coatings, paints or pre-applied long life primers).

APPLICATION

TEROSON PU 8545 UV may be applied thinly and evenly with felt applicator, sponge or brush.

For consistent results a wipe off is always recommended.

In order to control whether TEROSON PU 8545 UV covers the entire substrate, the product contains a UV indicator. It is particularly well visible under a UV lamp with a wave length of approx. 380 nm.

IMPORTANT

TEROSON PU 8545 UV contains reactive adhesion promoters, it should never be applied directly from the original bottle. Instead it should always be poured into small containers.

Our experience leads us to make the following recommendations:

- primer bottles must be closed tightly immediately after use
- active wipe which is obviously cloudy is spoiled and must not be used.
