# PRODUCT DESCRIPTION

Teroson RB 2750 provides the following product characteristics:

Teroson RB 2750 is a flexible, versatile applicable adhesive and sealing tape based on butyl rubber. It consists of a self-adhesive plasto-elastic butyl rubber material with high adhesive strength and is unilaterally laminated with a synthetic non-woven. Dimensionally stable in its lengthwise direction, it can be elongated crosswise up to 10 %.

Teroson RB 2750 is compatible with bitumen-containing substrates.

#### Notice

For outdoor applications, the synthetic non-woven must be painted over (with latex paints used for building purposes) in order to provide weathering protection.

# **Application Areas:**

Teroson RB 2750 is used for sealing sheet metal covers as well as ventilation ducts in interior and exterior applications. Further areas of use are sealing of connections and overlap joints of switchboards and the production of metal-based sandwich elements for sound absorption.

Teroson RB 2750 can be applied to smooth substrates such as aluminium, sheet zinc, polyester, glass, roofing foils based on ECB, EPDM, PIB, CR and other substrates. The tape can also be used in connection with acrylic glass (Plexiglass®) and polycarbonate (Makrolon®). In the event of use with other synthetics, our advice should be asked for and/or trials should be carried out by the user.

Teroson RB 2750 has to be put on the surface to be sealed and pressed on. Afterwards the opposite part must be put on and if necessary, the parts have to be fixed mechanically.
