# **Preliminary statement:**

Prior to application it is necessary to read the **Material Safety Data Sheet** for information about precautionary measures and safety recommendations. Also, for chemical products exempt from compulsory labeling, the relevant precautions should always be observed.

# **Pre-Treatment:**

The substrates must be clean, dry, free of oil, grease and release agents.

# Application:

Unroll Teroson RB 276 and cut it to the desired length. Then apply the tape to the surface requiring sealing and press it on. Experience has shown that it is best not to remove the release paper or film when unrolling the tape, but only after it has been applied and pressed on. In this way any unwanted stretching of the tape during application can be prevented and the sealing tape is protected from dirt. After peeling off the release paper, press on the mating part and fix the entire assembly mechanically, if necessary.
