Teroson RB 82 is a high quality, strongly adhesive sealing tape based on butyl rubber with plasto-elastic properties.

The particularly strong tackiness provides a firm lamination between the contact surfaces and, therefore, a reliable sealing effect. Higher temperature influence for a short time, normally paint curing process, has no adverse effect on quality and function. Teroson RB 82 is equiped with a hotmelt foil on one side and shows good absorption of structure borne- and vibration noise because of its high specific weight. Teroson RB 82 is aging resistant and is used for numerous application purposes due to its good adhesion to cleaned metallic and non-metallic material surfaces.

Preliminary statement:

After peeling off the release paper of foil from the Teroson RB 82 parts, the strips will be put on the damping surfaces and pressed on.

Surfaces or roars with high vibration will be covered or wrapped round with Teroson RB 82.
