The substrates must be clean, dry, oil and grease free.

Application:

Unroll Teroson RB 963 and cut it to the desired length. Then apply the tape to the surface requiring sealing and press it on. Experience has shown that it is the best not to remove the release paper or film when unrolling the tape, but only after it has been applied and pressed on.
