PRELIMINARY STATEMENT

APPLICATION

The material should be applied on both sides and twice if the material is very absorbent. The drying time is approx. 10 to 30 minutes. To improve thermal resistance, hardener e.g. Terokal 8311 (TEROSON SB 8311) up to 2.5 % can be added. The substrates must be free of dust and oil and must be fitted exactly together. For dilution and cleaning e.g. TEROSON R can be used. If required our technical service department will provide you more detailed information about use and application.
