## **Application**

Set heating system to 'warm' and fill the product into the cooling system while engine is running.

To ensure a constant product distribution, leave the engine running for 10 minutes or drive the car.

Afterwards, check fill level of the cooling system. If the leak is still present, the hole crack might be too big to be fixed with TEROSON VR 1200. The content of the 250ml can is enough for cooling systems with 6 - 8 litres total fill quantity.
