Application

Shake aerosol can well before spraying. Adjacent areas not to be painted should be covered in an appropriate fashion. Spray an even coat of product onto the wheel rim or any other surface to be painted from a distance of approximately 20–30 cm. Because the product is fast drying, a second coat can be applied shortly after the first coat (if required) or the vehicle may be quickly returned to service.
